capacity to assimilate nutrients. This has led to the formation of large algae mats and excessive macrophyte growth in and near the impounds created by the hydro facilities.

Currently the condition of the river is poor and because of the condition it offers limited recreational opportunities and has negatively impacted fish and wildlife in the river and its corridor.


The local governments represented by this Commission also represent thousands of rate payers in the region. Because of this, we are interested in making sure that demands on Idaho Power for mitigation are both necessary and affordable. Agriculture makes up nearly 70% of our regions economy and it is highly dependent on an affordable and adequate supply of electrical power.

IV. Conclusion

For the foregoing reasons, the Middle Snake Regional Water Resource Commission request intervention in this proceedings.

Dear Commissioners,

I am writing this letter from the commission to give you some background and our input on a possible lease or purchase of Bell Rapids water by the Bureau of Reclamation.

May 10, 1996

You are aware that the Bureau is mandated to lease or purchase four hundred twenty-seven thousand (427,000) acre feet of water from the Upper Snake River to be used as flushing flows for Salmon Smolt returning to the ocean. The Bureau is currently considering a lot of possible sources and one of them is the Bell Rapids Project. The Bureau is doing an assessment of Bell Rapids at this time and part of that assessment is an analysis of the economic impact of taking the land out of irrigated agriculture and returning it to dry grazing. The Bureau asked the University of Idaho to provide the analysis, which they did, using our regional economic model. The model indicates that taking the land out of production would have an impact on the region of about twelve million dollars (\$12,000,000). It would also impact property taxes in Twin Falls County by around two hundred thousand dollars (\$200,000) and reduce the labor force by forty-five (45) people. The laborers reside in both Twin Falls and Gooding Counties.

My commission members discussed the situation at length and finally decided to relay the facts of the situation to our county commissioners, but take no action as a commission at this time. Some members believe that the farm operations in the Bell Rapids area are marginal at best because of the cost of pumping the water from the Snake River. Deregulation of the electrical power industry may push these costs even higher, the high cost of power is dramatically apparent when comparing sales prices of farms in the project area with sales of land irrigated by other means in South Central Idaho.

Policy statement number three under the water quality portion of the Coordinated Water Resource Management Plan state "Mitigation of any negative impact on the residents of each county". Few people realize, however, that Federal law does not recognize economic impact on a region unless that impact exceeds one hundred million dollars (\$100,000,000). This situation clearly does not. If the Bureau leases or purchases other water from within the region, however, we could have a cumulative impact which would exceed the federal minimum.

An interesting side issue is that downstream water uses in Oregon and Washington can, through their state water laws, file on the water being sent downstream by the Bureau from our region. Idaho's economic loss is, therefore, an economic gain to the neighboring states. This may legislature will need to deal with this situation.

This commission seeks the following advice from it's member county commissioners pertaining to this issue.

- 1. Should this commission try to seek mitigation of damages to our region's economy if the Bell Rapids Water is leased or purchased by the Bureau for instream use or should we wait to see if the total water pulled from our region exceeds the one hundred million dollar (\$100,000,000) limit established by Federal Law?
- 2. Should we start a dialogue with the governor and area legislators concerning the appropriation of Idaho water by downstream water users in Oregon and Washington?

Review of <u>Joint Proposal</u> and <u>Coordinated Water Resource</u>
<u>Management Plan</u> with objective of applications for funding.

"No natural resource has ever withstood the devastating effects of uncontrolled exploitation by man," and the mid-reach of the Snake River is no exception to this premise.

In many cases the destruction is not visible, and thereby creating an urgent need for conservation. To achieve this end on such a broad and complicated problem as pollution in the mid-Snake requires considerable effort by many individuals. The results may become evident only after many years of research, study and implementation; yet delay in implementing some measures may result in loss of the resource.

Needs Assessment

- 1.It is necessary to obtain the facts detailed and specific that deals with research conducted now, or in the past on the problem. An overview of the programs that are on-going, or those which have been concluded and the results, objectives met, individuals responsible for the study, etc.
- 2. Definition of the sole authority (group or body) that will undertake the task, vested with the power for investigation, and chosen for their dedication and expertise. Sometimes, it will be necessary to have collaboration upon the studies, and at other times sole entities can provide the desired results. Personally, I would like to see the Governor give the study group the power to investigate, formulate the overview, and present the results for adoption, modification, and implementation. Is this possible? What are the other alternatives. To achieve long-term status, the group needs a power-driven command.
- 3. Specific time-lines for each phase of the study and project. Who will be responsible for each area?
- 4. One designated fiscal officer to administer the payrolls, disbursements, and reports. These can be extensive and are

crucial for the maintenance of the grant, and for applying for continued funding.

Objectives

1. To utilize a core-group for oversight of all activities

2. Compile all known data on studies, etc.

- 3. Examine the relationship between pollution and current land-use activities.
- 4. Develop a method for ranking water pollutant contributing

5. Identify ground water systems at risk.

- 6. Set standards for evaluation, and assessments for changes in land use, management or abandonment.
- 7. Work within a time-line with set objectives from each participating group, quantifiable outcomes expected
- 8. Media participation for volunteers, information, education and public awareness.

Methodology

- 1. Break the project into phases with the ultimate objective of implementation of the coordinated water resource management plan.
- 2. Establish office with full-time secretarial/computer support in Magic Valley or adjacent area.

Immediate concerns

- 1. Each group to submit a plan of what they expect to accomplish within a specified time line.
- 2. Each group submit known data from their entity on river pollution that is germaine to the study.
- 3. Each group submit resume of principal participant for funding sources.
- 4. Each group consider how services and expertise can be shared to out expenses.

Strategy

- 1. Establish a one-stop data center with a paid full-time employee, computer literate in supplying detailed information, graphics, etc.
- 2. FAX lines to all working partners in the study for shared information, paid for out of the grant funding.
- 3. Quarterly reviews and annual summation of objectives met; were the quantifiable goals realistic; and procedure for second-year program.

Submitted to the Middle Snake River Study Group May 15, 1996

Purpose of this outline

This document is a preliminary outline of the major content, production, and cost elements of a twenty-minute video program on waste water management in the Middle Snake River Basin. The information presented here is of a general nature and does not include the detail that will be included in the complete proposal and program script.

Program Overview

Purpose of the video

The video uses a positive approach to convince major Middle Snake River Basin water users to protect water quality through better waste water management. Three key concepts in the program are: 1) water is a public resource and all water users have an obligation to use water responsibly, 2) progressive operators are clean operators, and 3) the Middle Snake will recover through the efforts of industry groups promoting good waste

water management practices among their members.

How the program will accomplish its purpose

The program will show industry leaders using good waste water management practices and promoting responsible waste water management in their industry groups. All major water user groups will be shown, but the program will emphasize irrigated agriculture, CAFOs, and aquaculture because these are the industries with the largest numbers of independent operators who are most likely to be motivated by the positive examples of their peers. The program will use beautiful scenic footage and music to remind viewers that the Middle Snake River is a unique resource of inestimable value to all who use it.

Technical specifications and formats

The program will be produced to broadcast specifications and will use standard television production equipment and techniques. Studio and location material will be video taped in the Betacam videotape format, the program master will use the digital D-2 broadcast format, and distribution copies will be made in the VHS format. The program will be narrated by a professional broadcast narrator, and all copyrighted music used will be licensed to the production.

In the past twenty-three years Morgan Associates Television and Film has produced over fifty major documentary films for a wide range of clients including The National Geographic Society, state and federal agencies, major universities, and major corporations. Morgan Associates has produced seven different programs on environmental issues, among them *Crisis on the Snake* and *Action on the Snake*, two programs examining water quality problems on the Middle Snake River.





How SR³ fits into the Problem Solving Process



WHAT AREA DOES IT ENCOMPASS?

SR³ covers the Snake River from Jackson Lake in Grand Teton National Park, Wyoming, to Brownlee Dam on the Idaho/Oregon border. The river flows more than 700 miles in this reach and drains 72,590 square miles that includes lands and tributaries in Wyoming, Idaho, Nevada, and Oregon. Two Indian Reservations -- Fort Hall in Idaho and Duck Valley in Nevada are located in the basin.

Ten Reclamation projects are within the SR³ area: the Minidoka, Palisades, Michaud Flats, Little Wood River, Boise, Owyhee, Vale, Burnt River, Mann Creek, and Baker Projects. Facilities include 21 storage reservoirs and 5 hydroelectric powerplants. Other Federal, Tribal, private, and state facilities are also located within the SR³ area.

HOW ARE WE GETTING IT DONE?

A review of this magnitude requires a large team effort. Four people with the Bureau of Reclamation, located in Reclamation's Regional Office in Boise, Idaho, are leading the team.

Eileen Salenik, SR³ Manager, has extensive background and experience in resource planning and public involvement.

Lisa Wuttke, an engineer with planning and design experience, is the Water Resources Team Leader.

Chris Jansen Lute, Team Leader for natural, cultural and recreation resources, has worked on numerous planning teams as an outdoor recreation planner.

Carolyn Burpee Stone, a landscape architect with a background in planning and public involvement, is the Communications Team Leader.

Team members are meeting people, listening to discussions on issues, and visiting the water operation facilities and resources first-hand. We have met with water users, Tribal representatives, agencies, and others to discuss existing and new technologies, traditional and nontraditional partnerships, and current and changing resource uses. These efforts will continue.

We are discussing the possibility of partnerships with Idaho Power Co., the states of Idaho, Oregon, and Wyoming, and

five Tribal governments to address broader water related issues within the Snake River basin. In addition to partners, irrigation and agricultural communities, public and private interest groups, individuals, and other interested local, state, and federal agencies are invited to participate.

Public outreach is an integral part of SR³. Identifying people's issues and concerns about the Snake River system is crucial to developing a system that can address all issues. We need your help and encourage you to become involved in SR³! There will be regular updates of information about the process. If you would like to be on our mailing list, contact us as shown on the last page of this bulletin.

WHAT IS OUR SCHEDULE?

Developing the SR³ network system will take several steps. The first step, establishing internal technical work groups, has already taken place. These work groups are:


- Land Use/Soils
- Water Quality
- Recreation
- Cultural Resources and Indian Trust Assets
- Fisheries
- Wildlife & Vegetation
- Economic
- Irrigation/Water Contracts
- Ground Water
- Water Rights/Land Ownerships

- River/Reservoir Systems

Second, the technical work groups are conducting an inventory of the existing data to determine what data and information is available. Coordination with others who are gathering data and/or conducting studies on various components within the basin is a vital part of this effort. This inventory is scheduled for completion in 1996.

Selecting the SR³ databases and models and deciding how they will be linked together will follow the data inventory. The network system will be tested and refined on a section of the Snake River system that has comprehensive data coverage.

- water to satisfy contractual entitlements and irrigation diversions
- water to recharge aquifers (ground water)
- water for municipal and industrial use in the Treasure Valley and Magic Valley
- improved water quality
- water for recovery of endangered salmon in the lower Snake and Columbia rivers
- improved and increased recreation opportunities
- protection and enhancement of fish and wildlife habitat
- protection of endangered species
- protection of cultural resources and Indian trust assets

WHAT IS SR3?

The Snake River Resources Review (SR³) is a comprehensive review of the Snake River resources. There is a tremendous amount of information available about the resources in the Snake River basin. However, this information is in many different locations and formats. SR³ will consolidate basin information so it can be shared and used more efficiently. An information network and decision support system will be created that can link applicable information together. The network system will consist of two things:

Databases with information about the resources.

Computer Models that can simulate the river/reservoir system.

Linked information can be used to analyze the Snake River and reservoir system. The SR³ system will provide Reclamation, water users, and the general public with a clearer picture of resource capabilities and trade-offs. The system will be a key part of Reclamation's problem solving process in the future.





Per your request of March 1, 1996 I have enclosed a copy of the Coordinated Water Resource Management Plan for the counties making up the Middle Snake River Region. The Plan indicates that only three counties in the region have adopted the plan, but in the last three months Twin Falls, Minidoka and Cassia Counties have also adopted it. We are in the process of revising the plan to include these counties at this time. I have also included a video which was produced by our counties. It is actually the third video in a series of three, but it does an excellent job of describing our water quality concerns.



Secretary Babbitt and Commissioner Martinez have asked that I respond to your December 28, 1995 letter transmitting copies of the "Coordinated Water Resource Management Plan" developed by your Commission for Gooding, Jerome, Lincoln, and Twin Falls Counties. We commend your efforts in putting together a clear, concise, and thorough document that will serve to direct activities to maintain and improve the quality of water resources in your area. In general terms, Reclamation supports the goals, objectives, strategies, and policies presented in the document.

In fact, many components discussed in your plan coincide with a recent program implemented by Reclamation, the Snake River Resources Review (Review). Enclosed is a copy of a recent publication outlining the framework and purpose of the Review. The goals of the Review are to create an information network and decision support system to analyze the river and reservoir system and to provide both the public and governments a clearer picture of resource capabilities and tradeoffs in the Snake River Basin above Brownlee Dam. Copies of your report have been distributed to several of the Review's technical work groups to use in their efforts of compiling base information on resource related issues and concerns.

Dear Sir:

Pursuant to the federal Freedom of Information Act, 5 USC 552, as amended, I hereby request disclosure of the following information, documents and records for inspection and possible copying: your letter or comments to the Idaho Power Company concerning relicensing of power plants on the Mid-Snake River. The exact date is unknown, but it was written during the latter months of 1995. The phrase "information, documents and records," is used in a comprehensive sense and includes but is not limited to all hand-written, typed, printed, recorded, transcribed copies or reproductions of every kind and description. This includes letters, memoranda, telegrams, notes, reports, details of accounts, minutes, work sheets, computer printouts, contracts, proceedings and any type or other compilation from which information can be obtained.

If you regard any information, documents and records in the foregoing list as exempt from required disclosure under the Act, I hereby request that you exercise your discretion under the Act to disclose them nonetheless. I further request that you disclose the listed information, documents and records as they become available to you, without waiting until all information, documents and records have been assembled.

As you know, the Freedom of Information Act provides that if portions of a document or record are exempt from release, the remainder must be segregated and disclosed.

Therefore, I will expect you to send me all nonexempt portions of the information, documents and records that I have requested, and ask that you justify any deletions by reference to specific exemptions of the Act. I reserve the right to appeal your decision to withhold any information, documents and records.

I am making this request in the capacity of a journalist employed by Idaho working for Magic Valley Publishing, which publishes the Gooding County

Leader, Lincoln County Journal and North Side News.

The information, documents and records disclosed pursuant to this request will be used in preparation of news articles for dissemination to the public. As you know the FOI Act says search and copying fees "shall" be waived when the release of the requested information, documents and records would be "in the public interest." I believe this request plainly fits into this category.

Accordingly, I request that pursuant to the FOI Act provisions in question, you waive all fees in the public interest because the furnishing of the information, documents and records requested will primarily benefit the public.

If you deny this request for a fee waiver, however, and the fees will exceed \$10, please notify me of the charges before you fill the request so I may decide whether to pay the fees or appeal your denial of my request for a fee waiver.

I am making this request in the capacity of a journalist and the information, documents and records requested have timely value. I ask that if any questions arise concerning this request, you notify me by telephone rather than by letter. My office telephone is (208) 324-3391. I am normally there Monday through Friday 9 a.m. to 6 p.m.

I want to thank you for allowing me to answer your questions the other day. It was obvious that you had been considering the matter carefully and that's good. This is not something to entered into lightly. I also thank you for your vote to seek admission to the region. I don't think you will regret your decision. Our problems concerning water are the same and this region needs to be together on the important issues concerning our most valued resource.

There are some steps we must take to get Cassia County on line. It's only a formality, but the other member counties will be voting to accept Cassia at their next Commission meeting. Assuming this is a done deal, which I know that it is, there are some things you will need to do. I believe we can fast track your joining the Regional Commission by holding a hearing on the plan as it is written with the understanding that the plan will be changed to include Cassia in the history and other areas of the plan where necessary at a later date, probably within six months. The public hearing notice and the hearing format is the same that you use for your comprehensive land use plan. When you schedule your hearing let me know, and several of my commission members will be in attendance to field any questions from the public.

You should also try to locate two people who are willing to serve on this commission as soon as possible. Dear Interested Individuals, Organizations, and Agencies:

Today I would like to announce the availability of a final environmental impact statement (EIS) that I know will be of interest to you. This EIS evaluates alternatives to implement the acreage limitation and water conservation provisions of the Reclamation Reform Act of 1982 (RRA) throughout the 17 western United States.

Six alternatives, including no action, are analyzed. These alternatives consider a wide range of regulatory and nonregulatory actions for implementing the RRA on a westwide basis. The EIS concludes that the significance of impacts on a westwide basis is small; however, there may be local impacts in some areas under portions of some of the alternatives.

A new Preferred Alternative has been developed in response to public comments received on the proposed rules and draft EIS. This alternative proposes to greatly reduce paperwork for many districts and landholders by increasing the exemption from RRA forms requirements. It would also encourage users to voluntarily develop and implement water conservation plans under existing regulations and non-binding advisory guidelines, through a program of incentives and technical and financial assistance.

You will be receiving a copy of the Final EIS as soon as it is available from the printer. If you need to receive a copy sooner, please contact your nearest Reclamation area or regional office (see attached list) for an overnight photo copy.

I appreciate your interest and comments on the draft EIS. This final EIS will be used by the Department of the Interior and the Bureau of Reclamation to reach a decision regarding final regulations. You will be informed when a final decision is reached.

2. Assist in the coordination and scheduling of recharge events. This includes following-up with canal companies, agencies, and others actually

performing recharge.

6. Assist in the coordination of recharge monitoring programs.

7. Promote coalition development and support for recharge with Idaho water interests to insure coordination of recharge efforts for the entire aquifer.

8. Assist in coordination of recharge efforts as they may effect adjudication concerns.

AQUIFER RECHARGE COORDINATOR JOB DESCRIPTION

Background A continuing aquifer recharge program is undeniably a cornerstone of comprehensive water management for the Eastern Snake Plain Aquifer. Recharge, both natural and artificial, has been occurring across the aquifer for nearly 100 years and has yielded profound benefits to the economy of southern Idaho.

Due to the complexity of the task of coordinating all of the entities and activities involved in recharge, it is apparent from past experience that someone needs to "ride herd and keep the ball rolling." Otherwise something is bound to fall through the cracks and the parts and pieces simply don't fit together timely and efficiently. Recharge as a water management toof is particularly vulnerable to "apathy" because one good water year tends to erase memories regarding drought effects.

It is generally agreed among those of us close to the recharge program that we definitely need a recharge "point man." Those of us who led the way in 1995, including former aquaculture association executive director, Don Campbell, have agreed to continue our efforts in 1996. We believe we need to find someone, train, and tutor them for the job to insure future continuity in the recharge effort. It is a job that cannot logically be handled on a voluntary basis but rather should either be a salaried or consultant type position. We estimate it will cost between \$5000 and \$10,000 during the 1996 legislative session to fund the job.

Several of us have looked carefully at options for funding and have concluded that our best possibility for 1996 is to ask for voluntary contributions and work toward something more equitable in future years. We are suggesting the moneys contributed be collected and disbursed through the Lower Snake River Aquifer Recharge District according to mandates of an oversight committee made up of contributors.
